# **Midwifery Regulation**

We are ecstatic to announce that the proposed amendments to the *Midwifery Regulation* have been approved by government! Thank you for your patience while we determine the logistics for implementing the long-awaited (yet sudden!) changes.

The CMM has developed Education Modules related to the new additions to *Schedules* A and *B* in order to facilitate members' familiarization with these new lab tests and drugs. The required Education Modules are available online, with information having been sent to the members on May 1, 2017. All members must successfully complete the mandatory Education Modules and written exam prior to being able to order test or prescribe medication as per the expanded authority. September 1, 2017 is the deadline for completion for practising midwives.

Non-practising members may choose to not complete the education modules and exams in the immediate future; however they must be completed prior to return to practice.

The Committee has sincerest hopes that this package will help to support an informed discussion for moving forward on creating a plan for midwifery education and midwifery services in Manitoba.
