Honouring Indigenous Midwives

I had the privilege of being asked to attend the Manitoba Legislature on May 24th by member Darlene Birch, RM, to witness presentation of a Member's Statement by Bernadette Smith, MLA for Point Douglas, Winnipeg. The Statement outlined the historical significance of midwives to First Nations communities in decades previous, and the decrease of the practice over the last 100 years due to colonization and changes to the health care system. Ms. Smith honoured the four Indigenous midwives in Manitoba at present who she described as incredibly strong and providing essential care to women and their children throughout pregnancy, birth and postpartum – Darlene Birch, Nathalie Pambrun, Sandra Howard and Melissa Brown. #### Art From Tanzania

As you may recall, midwife He Hu gifted the College with an incredible art print at last year's AGM. He had received this print for her efforts in Tanzania from May 28 to June 11, 2017 where she volunteered to train the trainers and provided consulting services to develop the manuals for the Midwives Emergency Skills Training Program (MEST), the only training of its kind, geared specifically to midwives in Tanzania. The hope of the project – a collaboration between the Canadian Association of Midwives (CAM) and the Tanzania Registered Midwives Association (TAMA) – is that this effort will serve as a replicable model to support safe motherhood internationally. More recently, Megan Wilton, RM also went to Tanzania to teach emergency skills. The art print has been framed and was hung with pride in Patty's office.



## **COMMITTEE UPDATES**

## **Education Committee**

The Education Committee met in May 2018. There has been no significant movement towards continuing a midwifery education program or a gap training program in Manitoba. We would like to welcome Melissa Brown, RM (Non-prac), to the Education committee. Marla Gross, RM (Non-prac) will be stepping down as Chairperson in the fall of 2018 and leaving the committee, therefore we will be seeking another member. #### **Board of Assessors Committee**

The Board of Assessors Committee completed the registration renewals for the 2018-19 registration year. In the past year, five new midwives have been registered via the IMPP, the Ontario MEP and the Canada Free Trade Agreement. The Board of Assessors has reviewed all materials related to the *Standard on Supervision* and will be circulating an updated package shortly. In the coming year the Board of Assessors will also be the committee responsible for reviewing and approving applications for *Alternate Practice Arrangements*.

#### Standards Committee

The Standards Committee has been meeting regularly and continues to prioritize review of the Standard for Discussion, Consultation and Transfer of Care. Definitions and the Standard for Practice Protocols are also currently under review.

## **Quality Assurance Committee**

The Quality Assurance Committee has been busy with regular meetings. The committee is currently focusing on reviewing the Random Practice Audit portion of the Quality Assurance Program. The committee is also currently completing a review of the Terms of Reference. The committee would like to welcome new member, Nikki Ibbitt, RM.

## Canadian Midwifery Regulators Council (CMRC)

The CMRC has now transitioned to a new governance and leadership structure. For the past 11 years, Kris Robinson held the role of Chairperson and Patty Eadie served as the secretariat officer. CMRC has now restructured and hired a dedicated part-time Executive Director, Tracy Murphy, effective April 1, 2018. We look forward to working with Tracy and are thrilled to see the CMRC continue to grow and move on to this new phase of operations. We owe Kris and Patty so much thanks for putting their time and expertise towards ensuring the CMRC was able to do so much excellent work over the past decade. CMRC has grown in size and scope over the years under their thoughtful guidance.

## Reminders New Arrivals

#### Plan ahead for 2019!

All certifications in Cardiopulmonary Resuscitation, Neonatal Resuscitation, Emergency Skills and Fetal Health Surveillance must be current at the time of renewal – by March 31st at the latest. Now is a good time to plan ahead to ensure you have renewed all your required courses prior to the 2019 renewal period. Failure to submit confirmation of currency in these areas may result in suspension of your registration or restrictions on your practice.

## Non-Insured Health Benefits Program Updates

## Registered Midwives as Prescribers

Effective November 28, 2017, NIHB recognized registered midwives (RM) as prescribers of MS&E benefits within their scope of practice. This means that, in provinces and territories where midwifery is a regulated health profession, midwives can prescribe pregnancy-related items that are covered by the NIHB Program such as medical grade compression stockings, maternity belts and breast pumps.

## Increased coverage for Breast Pumps

On December 11, 2017 manual breast pumps became an open benefit when prescribed by an NIHB-recognized health provider (physician, nurse practitioner or midwife). Prior approval from NIHB is no longer required and the Program will pay up to a maximum of \$65 for a manual breast pump for the birth of each child.
